# 1. 2019 Meeting Schedule

Special Projects Manager Lawrence Thoo presented to the Board a schedule of meetings for 2019 with the Board retreat at a date and time to be determined by the Executive Committee.

## 2. WIOA Performance and Service Delivery Outcomes

work2future Director Monique Melchor reported on staff's assessment of CalJOBS's predictive reports and performance negotiations with the state. Ms. Melchor emphasized that the report is an interim indicator of performance due to the unavailability of WIOA performance reports from CalJOBS.

Ms. Melchor reviewed the performance goals negotiated and agreed with the state for Program Years 2018 and 2019. She pointed out that, despite the agreed goals, uncertainty remains with respect to the Credential Attainment indicator, as the state has yet to resolve continuing disagreement in the field about what does and does not count as a "credential" for Performance Indicator purposes.

Ms. Melchor also reviewed the employment-related outcomes of each of the career services providers, Eckerd Workforce Development and work2future Foundation, and reported that, as the first quarter results are short of goal, staff will be tracking the providers' outcomes closely as the year progresses. However, staff is not overly concerned at this time, she said.

Ms. Melchor responded to questions asked by Ms. Le, Mr. Estill, and Mr. Said.

### 3. Budget Update: Preliminary Budget Scenarios FY 2019-20

Finance Manager Joy Salandanan reported on the initial budget scenarios for Fiscal Year 2019-20. She pointed out that as the White House asked for an overall reduction in funding for Department of Labor of nine percent, including a 40 percent cut for WIOA, staff will be considering possible solutions to mitigate the

likely negative impact on funding to local workforce boards while still maintaining the health of the organization.

## 4. Skills Gap in the San Jose MSA

LMI Project Manager Bige Yilmaz introduced Justin Edwards and Jaime Garcia from Social Progress Imperative, Inc., who presented on their work to date analyzing the skills gap issue in the San Jose-Sunnyvale-Santa Clara Metropolitan Statistical Area as part of their efforts to develop a Social Progress Index (SPI) for San Jose. An SPI is an indicator of the social health of a community, measured across various criteria.
